ALGONQUIN TENNIS CENTER, INC. SUMMER OUTDOOR MEMBERSHIP AGREEMENT AND RULES
(Existing Shareholder)

This agreement is made and entered into by and between the Algonquin Indoor Tennis Center, Inc. (hereinafter the "Club"), and: Name: _____

WHEREAS, the Club desires to enroll a total of eighty (80) outdoor year-to-year Summer Members.

- (a) Right of first refusal is extended to existing Shareholders of the Club. This Summer Member agrees to pay the sum of one hundred fifty dollars (\$150.00) as a non-refundable application fee for an Outdoor Summer Membership. This payment shall be credited to the initial annual, all inclusive, Outdoor Summer Membership fee of \$600.00*, year-to-year, Family Membership for existing Shareholders, and extended to his/her spouse, and to unmarried dependent children who are under the age of twenty-one (21) residing at home or a full-time under graduate student. (All other new, year-to-year, Outdoor Summer Members shall pay \$750.00 annually for an all-inclusive Family Membership);
- (b) *2022 Pro-rated dues: June 1st or before \$600.00
(For Existing Shareholders) July 1st \$450.00
August 1st \$300.00
September 1st \$150.00
Future dues will be due and payable March 1st;
- (c) Application, \$150.00 deposit payable to AITC, Inc., and Waiver of Liability Form (found under Forms on website) **DUE NO LATER than 2/15/22** per Daniel Cronin, VP, Membership Committee Chair;
- (d) Algonquin Reservation System will be used to reserve the three (3) outdoor clay courts in two (2) hour time increments. Periods of play, seven (7) days per week: 7:00 AM – 9:00 AM, 9:00 AM – 11:00 AM, 11:00 AM – 1:00 PM, 1:00 PM – 3:00 PM, 3:00 PM – 5:00 PM, 5:00 PM – 7:00 PM, 7:00 PM – 9:00 PM. Open time may be reserved by any Outdoor Member up to seventy-two (72) hours in advance. No Member shall be entitled to reserve two (2) or more consecutive open time playing periods on the same day. Reservation cancellations must be done at least three (3) hours prior to commencement of the period of play involved to avoid a \$15.00 dollar (fifteen) late cancellation fee. Guests shall be allowed the privileges of the Outdoor Club only when a member is present and part of the group. A fifteen dollar (\$15.00) guest fee shall be billed to the host. No person shall be permitted guest privileges more than three (3) times per month. If a guest plays more than three (3) times per month the member who hosted the guest will on the fourth (4th) or following times be assessed a fee of thirty dollars (\$30.00 for each violation). A fine of twenty-

five dollars (\$25.00) in addition to the guest fee will be assessed against a member for failing to sign in or to pay for a guest;

- (e) Outdoor Summer Membership shall include use and access of the outdoor clay court facility, picnic area and parking lot. It shall not include entry in the building structure at Algonquin for any reason.
